INVITATION TO BID

The Police Regional Office 2 through PNP Trust Fund Receipt for the month of December 2021 intends to apply the sum of **One Million Five Hundred Thirty One Thousand Four Hundred Eighty Eight Pesos (Php1,531,488.00)** being the Approved Budget for the Contract (ABC) for the Upgrading of ICT Equipment (Rehabilitation & Upgrading of PRO2 Network) (**Public Bidding No.PRO2 2022-01**). Bids received in excess of the ABC shall be automatically rejected during Bid Opening.

The PRO2 now invites bids for the above Procurement Project. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project.

The bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations of R.A. 9184 known as the Government Procurement Reform Act”.

Interested bidders may obtain further information from the Police Regional Office 2 at the address below during working days from 8:00 AM to 5:00 PM.

A complete set of Bidding Documents may be acquired by interested bidders from **February 28 – March 21, 2022** from the address below upon payment of a non-refundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (Php5,000.00)**.

Police Regional Office 2 will hold a Pre-Bid Conference on **March 8, 2022 at 9:00 AM** at PRO2 Conference Room through video conferencing via zoom. Prospective bidders who are interested to join the Pre-Bid Conference via zoom may send request for Zoom Link Password to the pro2_rld@yahoo.com.ph day before the scheduled conference.

Bids must be delivered to the address below on or before **March 21, 2022 at 9:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid Opening shall be on **March 21, 2022 at exactly 9:15 AM at PRO2 Conference Room**. Bids will be opened in the presence of Bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

Bidders should comply with the applicable provisions of Section 23.4.1.1 of 2016 Revised IRR of R.A. 9184 (Eligibility Criteria for Procurement of Goods) and with a modified set of requirements integrating eligibility documents and criteria for procurement of goods as provided in Annex D of the 2016 revised IRR of RA No. 9184

The Police Regional Office 2 reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without incurring any liability to the affected bidder/s.

Further, Police Regional Office 2 assumes no obligation to compensate any bidder/s for any loss or expense incurred in the preparation of the bid documents or participation in the bidding process.
