PRO2 BAC RESOLUTION NO. 2021-65

“RESOLUTION DECLARING TRUST TRADE AS THE LOWEST RESPONSIVE BID FOR THE SUPPLY & DELIVERY OF 9MM AMMUNITION FOR THE MONTH OF DECEMBER 2021”.

WHEREAS, PRO2 Bids and Awards Committee (BAC) has resorted to the alternative mode of procurement through Negotiated Procurement-Small Value Procurement under Section 53.9 of the 2016 Revised Implementing Rules & Regulations of RA 9184 for the Supply and Delivery of 9MM Ammunition for the month of December 2021;

WHEREAS, the Request for Quotation for the Supply & Delivery of 9MM ammunition for the month of December 2021 with an Approved Budget for the Contract (ABC) in the amount of **Five Hundred Thirty One Thousand Nine Hundred Sixteen Pesos and 67/100 (Php531,916.67)** was posted at the Philippine Government Electronic Procurement System (PhilGEPS) and letters of invitation were sent to three prospective suppliers namely: Precisions Munitions Inc., TRUST TRADE and Armscor Shooting Center Inc. from December 2-9, 2021;

WHEREAS, in response to said request for quotation Armscor Shooting Center Inc. and TRUST TRADE submitted their bid proposals;

WHEREAS, during the opening of bid proposal on December 9, 2021, TRUST TRADE was ranked as the 1st Lowest Calculated Bid and Armscor Shooting Center Inc. as the 2nd Lowest Calculated Bid and both passed the eligibility criteria and the minimum specification set by the PNP for 9MM ammunition and both were declared eligible as follows;

WHEREAS, having both passed the bid opening and evaluation TRUST TRADE was declared as the Lowest Calculated Bid subject to product test and evaluation by the Technical Working Group on Goods;

NOW THEREFORE, on unanimous accord of all members present, be it




