PRO2 BAC RESOLUTION NO. 2022-02

"RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD THE CONTRACT TO RTC CONSTRUCTION FOR THE CONSTRUCTION OF STANDARD TYPE "B/C" MPS BUILDING OF LAL-LO PS, CAGAYAN PPO"

WHEREAS, the PRO2 Bids and Awards Committee (BAC) continuously posted the Invitation to Bid for the proposed **Construction of Standard "B/C" MPS Building of Lal-lo Police Station, Cagayan PPO** with an Approved Budget for the Contract (ABC) in the amount of **Six Million Four Hundred Eighty Five Thousand Pesos (Php6,485,000.00)** from October 20, 2021 to December 13, 2021 at the Philippine Government Electronic Procurement System (PhilGEPS), PRO2 Website and conspicuous places at Police Regional Office 2;

WHEREAS, in response to the said advertisement, four (4) proponents purchased the bidding documents and submitted their bid proposals before the deadline of submission on December 13, 2021 namely: RTC Construction; 7Chin Builders and Construction Supply, MLR Solid Construction and VQM Construction;

WHEREAS, during the preliminary examination of the bid documents VQM Construction was rated failed (the certificate of site inspection is not in substantial compliance with the requirements pursuant to ITB Clause 24 of the Instruction to Bidders of the Bidding Documents and Section 30 of the 2016 Revised IRR of RA 9184) and was declared disqualified. Likewise, 7chin Builders and Construction Supply also was rated failed (the JVA is not in substantial compliance with the requirements) and was declared disqualified;

WHEREAS, RTC Construction and MLR Solid Construction passed the non-discretionary passed/fail eligibility criteria and were declared eligible:

WHEREAS, RTC Construction was declared as the Bidder with the 1st Lowest Calculated Bid subject to Post-Qualification by the TWG on Infrastructure;

WHEREAS, the Technical Working Group (TWG) conducted post qualification to RTC Construction and was found to be compliant on all the documentary requirements and with a responsive bid;



NOW THEREFORE, on unanimous accord of all members present, be it

RESOLVED, AS THE PRO2 BIDS AND AWARDS COMMITTEE HEREBY RESOLVED to recommend to the Head of the Procuring Entity (HOPE) to award the contract for the **Construction of Standard Type "B/C" MPS Building of Lal-lo PS, Cagayan PPO to RTC Construction.**


