PRO2 BAC RESOLUTION NO. 2022-12

"RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD THE CONTRACT TO ZHEG HOME AND OFFICE DECOR TRADING FOR THE SUPPLY AND DELIVERY OF FURNITURE AND FIXTURES FOR THE NEWLY COMPLETED POLICE STATION FOR FY 2020".

WHEREAS, PRO2 Bids and Awards Committee (BAC) has resorted to the alternative mode of procurement through Negotiated Procurement-Small Value Procurement under Section 53.9 of the 2016 Revised Implementing Rules & Regulations of RA 9184 for the Supply and Delivery of furniture and fixtures for the newly completed Police Station for FY 2020.

WHEREAS, the Request for Quotation for the of furniture and fixtures for the newly completed Police Station for FY 2020 with an Approved Budget for the Contract (ABC) in the amount of **Four Hundred Fifty Thousand Pesos (Php450,000.00)** was posted at the Philippine Government Electronic Procurement System (PhilGEPS) and letters of invitation were sent to three prospective suppliers namely; Devas General Merchandise, Dangayan Creative Solutions & General Merchandise and RGP Enterprise from **February 25, 2022 – March 4, 2022**;

WHEREAS, in response to said request for quotation two (2) suppliers namely: ZHEG Home & Office Decor Trading and Real Form Furniture Shop submitted their bid proposals;

WHEREAS, during the opening of bid proposal on March 4, 2022 the two suppliers passed the non-discretionary passed/fail eligibility criteria and were declared eligible:

WHEREAS, having passed the bid opening and evaluation **ZHEG Home & Office Decor Trading** was declared as the Bidder with the Lowest Calculated/Responsive Bidder subject to product evaluation;

WHEREAS, after product evaluation **ZHEG Home & Office Decor Trading** was found to be compliant on the required specification set by the PNP and with a responsive bid;



NOW THEREFORE, on unanimous accord of all members present, be it **RESOLVED**, **AS THE PRO2 BIDS AND AWARDS COMMITTEE HEREBY RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) to award the contract for the Supply and Delivery of furniture and fixtures for the newly completed Police Station for FY 2020 to **ZHEG Home & Office Decor Trading**.
