PRO2 BAC RESOLUTION NO. 2022-14

"RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD THE CONTRACT TO SIFFU ROCKS CONSTRUCTION FOR THE CONSTRUCTION OF PRO2 RIDERS' NOOK - PHASE 1"

WHEREAS, PRO2 Bids and Awards Committee (BAC) has resorted to the alternative mode of procurement through Negotiated Procurement –Small Value Procurement in accordance with Section 53.9 of the 2016 Revised Implementing Rules and Regulations of RA 9184 for the Construction of PRO2 Rider's Nook - Phase 1;

WHEREAS, the Request for Quotation for the **Construction of PRO2 Rider's Nook - Phase 1** with an Approved Budget for the Contract (ABC) in the amount of **Three Hundred Fifty Thousand Pesos (Php350,000.00)** was continuously posted from February 25, 2022 – March 4, 2022 at the Philippine Government Electronic Procurement System (PhilGEPS), PRO2 Website and conspicuous places at Police Regional Office 2 and letters of invitation were sent to three prospective proponents namely: RTC Construction, Deceries Construction and G-Mars Construction;

WHEREAS, in response to the said advertisement, only Siffu Rocks Construction responded to the PhilGEPS post and submitted its bid proposal;

WHEREAS, during the opening of quotation on March 4, 2022, Siffu Rocks Construction passed the non-discretionary passed/fail eligibility criteria and was declared eligible with a bid amount of **Three Hundred Forty Nine Thousand Nine Hundred Ninety Pesos (Php349,990.00)**;

WHEREAS, Siffu Rocks Construction was declared as the Bidder with the Single Calculated/Responsive Bid subject to Post-Qualification by the TWG on Infrastructure;

WHEREAS, the Technical Working Group (TWG) conducted post qualification to Siffu Rocks Construction and found to be compliant on all the documentary requirements with a responsive bid;

NOW THEREFORE, on unanimous accord of all members present, be it **RESOLVED**, AS THE **PRO2 BIDS AND AWARDS COMMITTEE** HEREBY **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) to award the contract for the **Construction of PRO2 Riders' Nook – Phase 1** to **Siffu Rocks Construction**.


